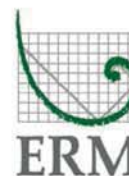

De Beers Consolidated Mines (Pty) Ltd (DBCM) has appointed Environmental Resources Management Southern Africa (Pty) Ltd (ERM), as the independent environmental consultants to undertake the Environmental Impact Assessment (EIA) process for the proposed Waste Management Licence Application for the listed activities associated with the upgrade of the Waste Management Facility (WMF) and establishing a designated area on the waste rock dump for the disposal of demolition and building materials at the Venetia Diamond Mine (Venetia), Limpopo Province.

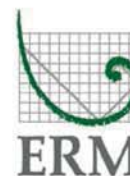

Project Description

Venetia Mine is an existing open pit mine and recently (July 2012) Environmental Authorisation (EA) for the development of underground workings and an amendment of the existing Environmental Management Plan (EMP). DBCM anticipates that the current open pit mining operations will cease between 2020 and 2023 subject to market conditions, production targets and open pit mining scenarios, after which only underground operations will continue.

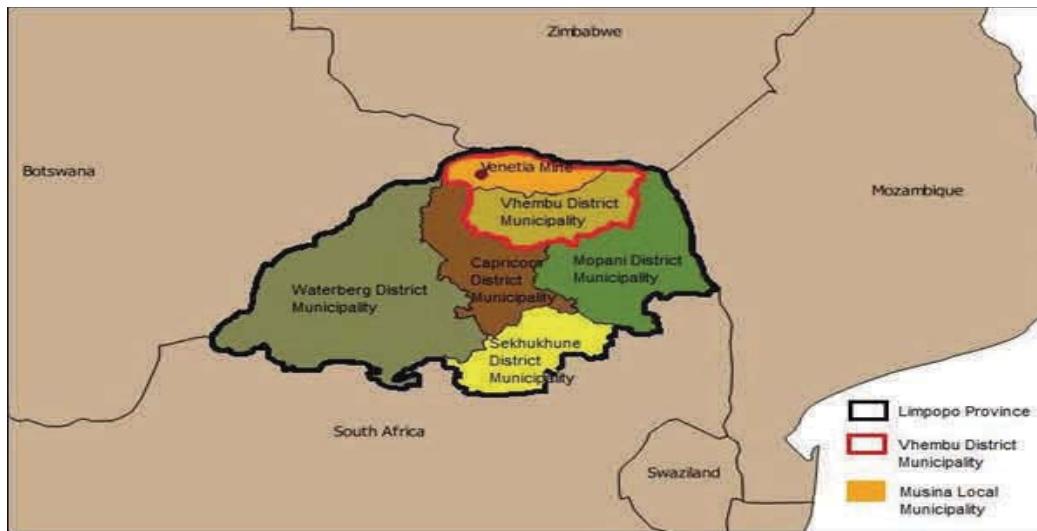
PROJECT DESCRIPTION

Project Locality

Venetia Mine is situated on the farm Venetia 103MS , Krone 104MS, Rugen 105MS, Drumsheugh 99MS, which lies approximately 80km west of Musina and 40km north east of Alldays in the Limpopo Province of South Africa. Venetia is situated off the R521 between Alldays and Pontdrift, approximately 550 km north of Johannesburg.

The mine is located within the Musina Local Municipality of the Vhembe District Municipality. The border with Botswana and Zimbabwe is situated approximately 30km to the north.

Waste Management Licence (WML) Application

Project Background

Venetia Mine is an existing open pit mine that recently (October 2012) received an Environmental Authorisation (EA) and positive record of decision from DMR from the Limpopo Department of Economic Development, Environment and Tourism (LEDET) for the development of underground workings and an amendment of the existing Environmental Management Plan (EMP). Open pit mining operations are expected to cease between 2020 and 2023, after which only underground operations will continue. The Waste Management Licence application is being undertaken to license the listed activities associated with the upgrading of the Waste Management Facility (WMF) and designated disposal area for construction, demolition and building materials from mining operations in order to meet the legislative requirements in terms of the National Environmental Management: Waste Act (Act 59 of 2008).

Need and Desirability of the Project

Current waste management activities and facilities at Venetia can be revised and upgraded and once more formalised (as per the proposed project scope), the on and off-site management of waste will become more streamlined. The proposed waste management activities listed in GN R.921 include:

- construction and expansion of a facility for waste management;
- sorting, shredding, grinding, crushing, screening or bailing of general waste;
- recycling of general waste;
- recovery of waste including the refining, utilisation, or co-processing of waste;
- reuse or recycling of hazardous waste;
- treatment of hazardous waste; and
- disposal of inert waste to landfill.

The key objective of the Integrated Waste Licensing application for Venetia Mine is to reach a state of full compliance in respect of the various waste management activities as soon as is practically possible.

The Waste Management Facility (WMF)

The WMF (previously referred to as the salvage yard) is an area currently used to collect waste for sorting, laydown, re-use, recycling and screening before final disposal. General as well as hazardous wastes are received, stored, sorted, recycled and finally (where possible) transferred from the mine for final disposal. Currently, almost all waste streams collected at the mine pass through this facility.

The WMF is an existing facility but expansion is proposed (as per this application) and Venetia Mine seeks to formalise this area.

Although this application is not for any mineral waste, it is proposed that various types of waste be disposed of within the existing Waste Rock Dumps (WRD) due to various difficulties with removing these wastes from site. The types of waste proposed to be disposed of on the WRD include earth moving vehicle (EMV) tyres , light duty vehicle (LDV) waste tyres, building rubble, demolition and construction wastes and wooden waste.

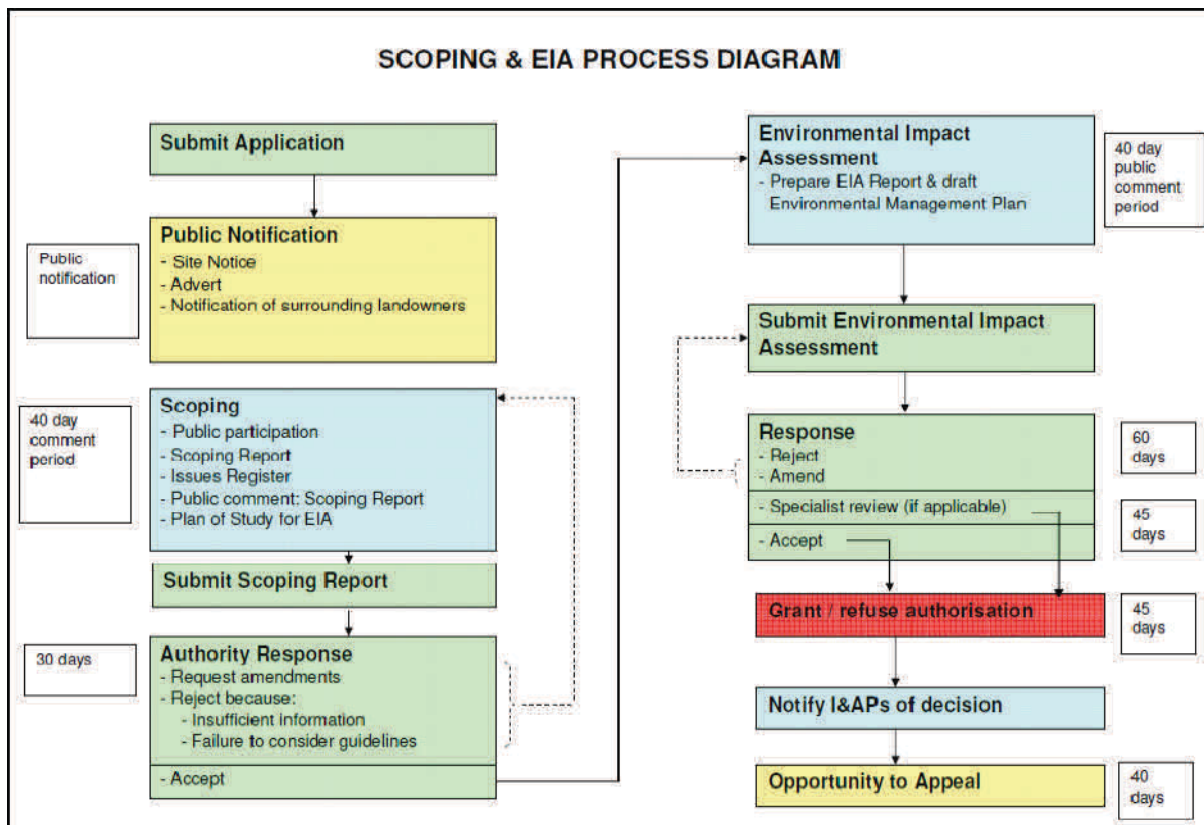
National Environmental Management: Waste Act (Act 59 of 2008), as amended

The National Environmental Management: Waste Act, 2008 (Act No. 59 of 2008) came into effect on 1 July 2010 and repealed Section 20 of the Environmental Conservation Act, 1989 (Act No. 73 of 1989), introducing new provisions with regards to the licensing of waste management activities. The National Environmental Management: Waste Amendment Act (Act 26 of 2014) was promulgated on 2 June 2014 and repealed or replaced various sections of NEMWA.

The list of waste management activities that have, or are likely to have, a detrimental effect on the environment were promulgated on 29 November 2013 (GN R. 921). According to GN R.921, a person who wishes to commence, undertake or conduct:

- an activity listed under Category A, must conduct a Basic Assessment process; or
- an activity listed under Category B, must conduct a Scoping and EIA process.

There are a number of both Category A and Category B listed activities at Venetia Mine and, as such, a full Scoping and EIA is required for this Waste Management Licence application. The National Environmental Management Act (NEMA) EIA Regulations must be followed, with a successful application resulting in the issuing of a **Waste Management Licence**. The relevant published Norms and Standards will also be considered.

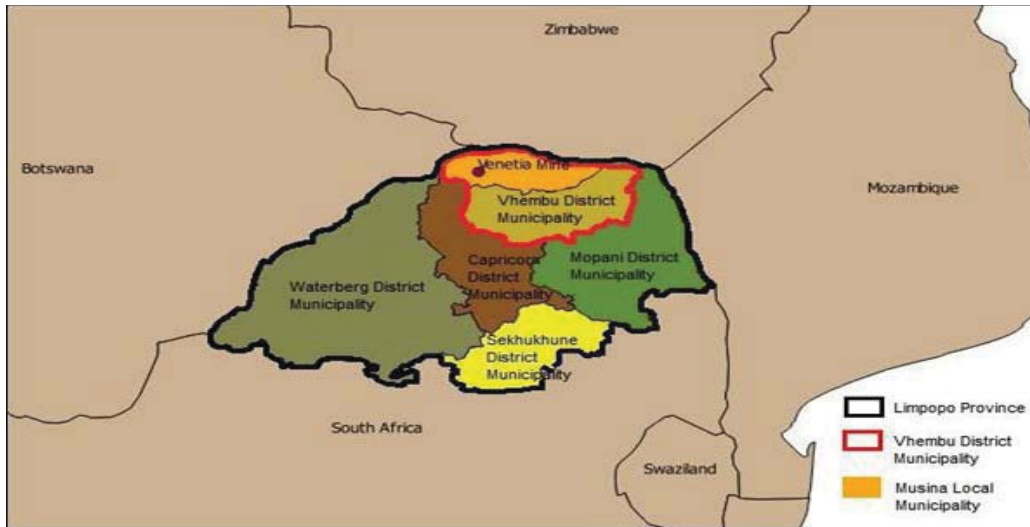
PROJEKBESKRYWING

Projekligging

Die Venetia-diamantmyn is op die Venetia 103MS-, Krone 104MS-, Rugen 105MS- en Drumsheugh 99MS-plase geleë, wat ongeveer 80 km wes vanaf Musina en 40 km noord-oos vanaf Alldays in die Limpopo-provinsie van Suid-Afrika lê. Venetia is duskant die R521 tussen Alldays en Pontdrift, ongeveer 550 km noord vanaf Johannesburg geleë.

Die myn is binne die Musina plaaslike munisipaliteit vanaf die Vhembe-distriksmunisipaliteit geleë. Die grens by Botswana en Zimbabwe is ongeveer 30 km na die noorde geleë.

Aansoek vir 'n lisensie vir afvalbestuur (ABF)

Projekagtergrond

Die Venetia-diamantmyn is 'n bestaande oopskagmyn wat onlangs (Oktober 2012) 'n omgewingsmagtiging (OM) en positiewe rekordsbesluit van DMR by Limpopo se Departement van Ekonomiese Ontwikkeling, Omgewingsake en Toerisme (LEDET) ontvang het vir die ontwikkeling van ondergrondse bedrywighede en 'n wysiging van die bestaande omgewingsbestuursplan (OBP). Die verwagting is dat oopskagmynbedrywighede tussen 2020 en 2023 beëindig sal word, waarna slegs ondergrondse bedrywighede sal voortgaan. Die aansoek vir 'n lisensie vir afvalbestuur word tans onderneem ten einde die gelyste aktiwiteite te lisensieer, wat met die opgradering van die afvalbestuursfasiliteit (ABF) verband hou, asook die aangewese wegdoeningsgebied vir konstruksie-, sloopings- en boumateriale afkomstig van mynbedrywighede ten einde aan die wetgewende vereistes kragtens die Wet op Nasionale Omgewingsbestuur: Afval (Wet 59 van 2008) te voldoen.

Behoeftes en wenslikheid van die projek

Huidige afvalbestuursaktiwiteite en -fasiliteite by Venetia kan hersien en opgradeer word, asook weereens wettig verklaar word (soos volgens die voorgestelde projekomvangbepaling). Die hoofdoelstelling van hierdie aansoek vir 'n lisensie vir geïntegreerde afval, het ten doel dat die Venetia-diamantmyn volledige nakoming kan bereik met betrekking tot die verskeie afvalbestuursaktiwiteite, sodra dit prakties moontlik word.

Die afvalbestuursfasiliteit (ABF)

Die ABF (wat voorheen as die "bergingswerf" bekend gestaan het) is 'n gebied wat tans gebruik word vir die sortering, bepaling, herbenutting, herwinning en keuring van afval wat ingevorder word voor die finale wegdoeningsproses. Algemene sowel as gevaarlike afvalmateriaal word hier ontvang, geberg, gesorteer, herwin en dan uiteindelik (waar moontlik) vanaf die myn vir finale wegdoening oorgeplaas. Byna alle afvalstrome wat by die myn ingesamel word, word tans deur hierdie fasiliteit gestuur.

Die ABF is 'n bestaande fasiliteit, maar uitbreiding word voorgestel (soos volgens hierdie aansoek) en die Venetia-diamantmyn beoog om hierdie gebied wettig te verklaar.

Daar word voorgestel dat daar weggedoen word met verskeie soorte afval binne die bestaande afvalklip-stortterreine weens verskeie probleme om hierdie afvalmateriaal vanaf die perseel te verwyder, alhoewel hierdie aansoek nie vir enige mineraalafval bestem is nie. Die soorte afval vir voorgestelde wegdoening op die afvalklip-stortterrein sluit grondverskuiwingvoertuigbande, liggewigvoertuig-afvalbande, bouafval, slopings- en konstruksieafvalmateriaal en houtafval in.

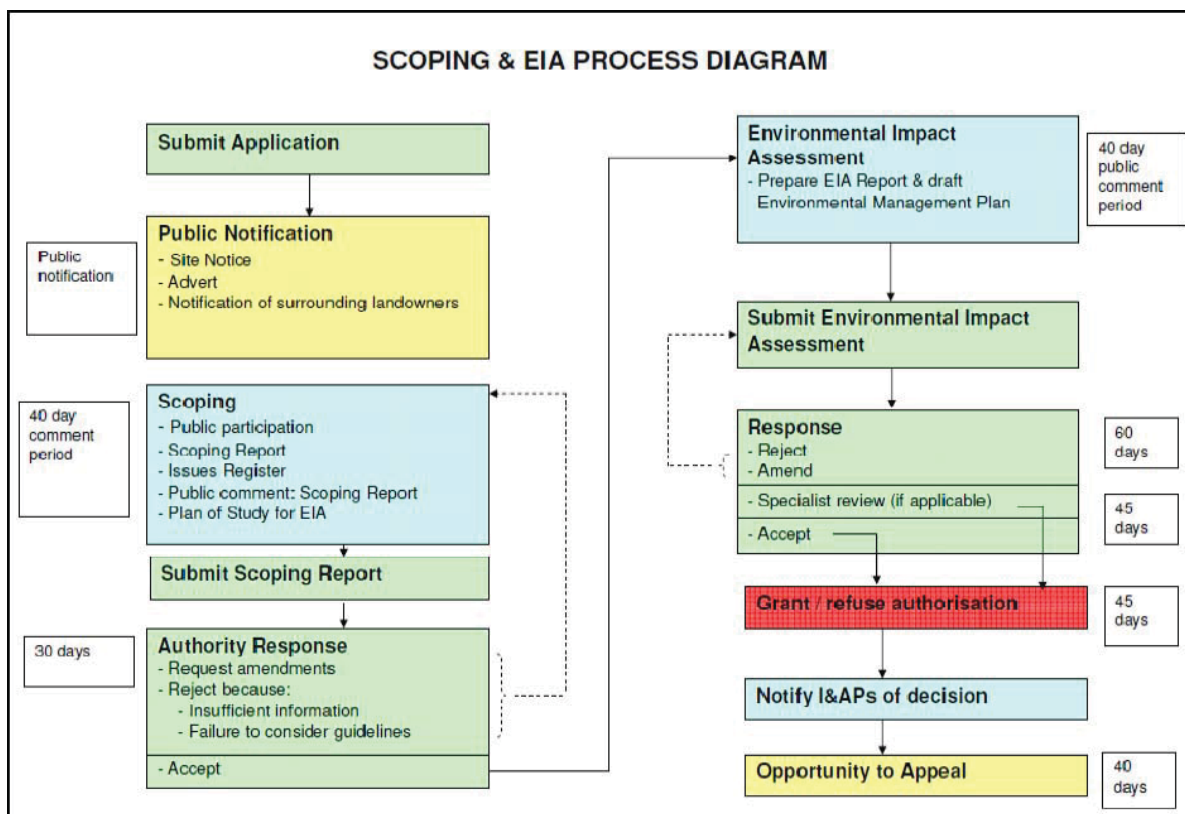
Wet op Nasionale Omgewingsbestuur: Afval (Wet 59 van 2008), soos gewysig

Die Wet op Nasionale Omgewingsbestuur: Afval, 2008 (Wetnr. 59 of 2008) het op 1 Julie 2010 in werking getree en het Afdeling 20 van die Wet op Omgewingsbewing, 1989 (Wetnr. 73 van 1989) herroep en nuwe voorwaardes bekend gestel met betrekking tot die lisensiering van afvalbestuursaktiwiteite. Die Wysigingswet op Nasionale Omgewingsbestuur: Afval (Wet 26 van 2014) is op 2 Junie 2014 uitgevaardig en het verskeie afdelings van NEMWA herroep en vervang.

Die lys van afvalbestuursaktiwiteite wat tans of waarskynlik in die toekoms 'n nadelige uitwerking op die omgewing sal hê, is op 29 November 2013 (GN R. 921) uitgevaardig. 'n Persoon wat volgens GN R.921 graag 'n aktiwiteit wil aanpak, onderneem of uitvoer:

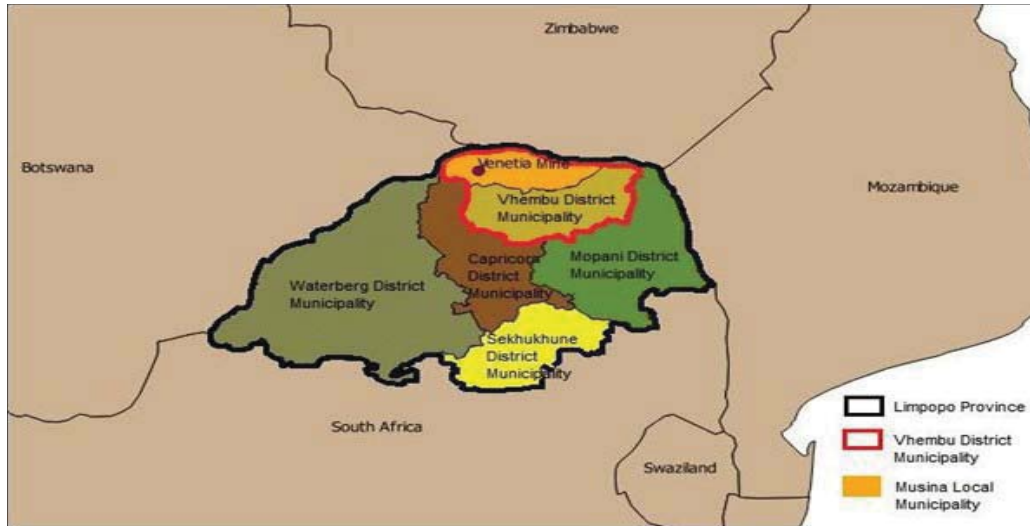
